1. Mediation fees at VICMC:

a. *The Registration fee:* 3.000.000 VND. This fee shall not be refundable in all circumstances.

- The costs for using the facilities for mediation (joint meeting room; private meeting rooms) as well as for lunch and refreshments; and
- Meditator fees.

Mediation fees excludes:

- Travel, accommodation and other costs of the mediator in the event that the parties request the venue of mediation not in urban center of Hanoi or Ho Chi Minh City or the mediator does not reside in the venue of mediation.
- The cost of facilities for mediation at the parties' requests without using the facilities Center offered, including: joint meeting room, private meeting rooms and lunch and refreshments. The center will not refund partial cost to the parties in this event.
- Other costs arising from the requests of a party or the parties (for example, translation costs)

3. Mediation fees to be negotiated:

In the following circumstances, the mediation fees will be agreed upon by the mediator(s) and the parties or decided by the President of the Center:

- Value in dispute from 200 billion VND;
- The dispute is resolved by more than 01(a) mediator;
- The dispute is resolved by international mediator;
- The parties did not specify the value of the dispute;
- · Disputes in specific areas.

Negotiation and decision on mediation fees will be made in considering the following matters:

- the number of mediators conducting mediation;
- Value of the dispute;
- The complexity of the dispute;
- Time to resolve the dispute.
